## Lawrence Country Club Terms of Agreement

Please Read and Understand These Terms Prior to Signing the Membership Application

- 1) **Parties.** This agreement is by and between you and Lawrence Country Club and its assignees. You agree that by signing this agreement, you have purchased a membership and agree to all the terms in this agreement as well as all other rules and regulations of the club.
- 2) **Membership.** This agreement is for membership in Lawrence Country Club. Your membership allows you the use of the club facilities as defined by your membership classification. You are required to comply with the terms of this agreement, including Lawrence Country Club By-Laws, and all rules and regulations adopted by Lawrence Country Club from time to time.
- 3) **Initial Term and Renewal of Membership.**
  - a) **Contracted Membership.** This membership shall be subject to the initial term set forth on the membership application. After the initial term, your membership will be automatically extended on a month-to-month basis, and may be cancelled with a mandatory 30-day written notice of cancellation. If, prior to the expiration of the initial term, you change your residence outside a 25-mile radius of Lawrence Country Club, you may terminate this agreement as long as we have received at least 60 days prior written notice and legitimate verification of your new address. Membership rates are locked in to the term length of the agreement.
  - b) **Termination.** Lawrence Country Club may terminate this agreement and the membership according to the Lawrence Country Club By-Laws.
  - c) **Transfers/Refunds.** This membership is not transferrable or refundable.
  - d) **Membership Rates.** Membership rates are subject to change with LCC Board approval.
- 4) **Payment Terms.** By signing this agreement, you agree to pay all recurring membership dues, unpaid dues, applicable taxes, retail transactions and other miscellaneous charges, service fees, assessments, and past unpaid dues and fees.
  - a) **ACH Option.** By completing the ACH option on the membership application, you hereby authorize LCC to deduct payment by ACH from a checking or savings account through the bank or financial institution you have designated until such time as you revoke your authorization for that form of payment by written notification delivered to the club in person or postmarked via certified mail.
  - b) **Late Payments and Suspension.** Any payment(s) made after the last day of each month are subject to a late fee not to exceed the lesser of 1.5% or the maximum amount allowed under Kansas Law. If you fail to make any payment under this agreement within 60 days of the scheduled due date, your membership will be suspended according to LCC By-Laws. Under suspension, you will have no access to Lawrence Country Club until timely payment has been made, at which time your rights under this agreement will be restored. Dues and any applicable fees will still be charged to accounts under suspension.
  - c) **Attendance.** Your non-use of Lawrence Country Club will not relieve you of your obligation to make payments as outlined herein.
  - d) **Default.** Should you default on your payment obligation, you agree to pay all costs of collection, including court costs and attorney's fees, to the fullest extent permitted by applicable law.
- 5) **Lost and Found.** Lawrence Country Club is not responsible for personal items lost or left at Lawrence Country Club. Any items found at Lawrence Country Club will be kept for thirty (30) days and then donated or discarded.
- 6) **Valuables.** For your protection, do not bring valuables into Lawrence Country Club. Lawrence Country Club is not responsible for or liable to you for damaged, lost or stolen items. We are not liable for any stolen, damaged or tainted property while on or around the LCC facility(s). Including but not limited to locker rooms, vehicles, lounges, dining facilities, tennis courts, pool, and pool facilities.
- 7) **Damages.** You shall pay for any damage to Lawrence Country Club's property by you, your guests, or dependent children.
- 8) **Injury or Accident.** Any injuries or accidents must be reported immediately to Lawrence Country Club.
- 9) **Club Rules.** For your safety, you must abide by Club rules, posted or un-posted, at all times, as adopted from time to time.
- 10) **Notices.** Unless you notify LCC in writing of any change in your address or e-mail address, any notices we send you are sufficient if sent to your address or e-mail address as shown on this application.
